Please note that there are entrance ramps that correspond to your booth space. Set up times are assigned because some spaces cannot be accessed once other vendors are in place.

You will receive a map of the Market Place showing your space, a letter of receipt, and tickets for continental breakfast. We suggest you keep a copy of this application for your records. Bring your letter of receipt with you.

Personal checks will be accepted up to August 1, 2012.

Note: After August 1, 2012, only a cashier's check or money order will be accepted or your application will be returned unprocessed and no space will be reserved. NO REFUNDS will be processed after May 1, 2012.
